## **Conduct of Judicial Officers**

Apart from the provisions contained under U.P. Government Servants Conduct Rules, 1956, various administrative directions issued by the Allahabad High Court in the form of **circular letters** govern and regulate the conduct of judicial officers. The Supreme Court (while giving approval to the report of the Shetty Commission) has clarified that the judicial officers are not government servants like other executive officers or officials acting under the control of State Governments or Central Government but they are **constitutional functionaries** as they perform their judicial function independently under the constitutional mandate and not under the control of any governments. Very high degree of moral and ethical values and conducts are always expected from the judicial officers.
